## **IMPORTANT NOTE #2**

**You will NOT be considered for a scholarship if your application is incomplete.**

## **IMPORTANT NOTE # 3**

**Interviews** will be conducted at a later date.

Scholarship recipients are selected based on individual applications meeting eligibility and criteria requirements.

Most scholarships are provided as cash awards in the form of a check made out to the recipient and their intended school unless otherwise indicated in the sponsor description. Scholarship checks are mailed after Bridgeport FFA Booster Club receives the required documentation. If selected to receive a scholarship, recipients must return a completed acceptance agreement form, a copy of the official class schedule (showing the recipient is a full-time student for the first term in school). All scholarships are paid with the understanding that, unless otherwise indicated, the money will be used for tuition, fees, books and equipment required for classes to attain a vocational diploma or college degree from a post-secondary vocational/technical school or from a college or university.

NOTE: Recipients are required to provide a valid mailing address within the United States and attend school within the United States. Scholarship checks will not be mailed outside the U.S.
